Grand Valley Fall Fair September 23, 24, 25, 2016 Exhibitor & Vendor Space -Application Form

This year, the 2016 edition of the Grand Valley Agricultural Society will be hosting its most exciting celebration of Ontario country living and farming - the annual Grand Valley Fall Fair! Our 144th!

1) A limited number of "Blank slate" Eight Foot "Single" booths, including table and two chairs, are available to exhibitors for the entire weekend event. Early bird price is just \$100, prior to June 15th. (After June 15th, \$200). A limited number of "Double" booths are also available with an Early Bird price of just \$200, prior to June 15th. (After June 15th, \$400).

This provides an outstanding marketing opportunity for businesses large and small, appealing to consumers throughout the Headwaters Region. (eg. *merchants, designers, artisans, consultants, bridal services, home-based businesses, craft vendors, growers, bakers, marketing boards, renewable energy suppliers and much more*).

Larger, custom sized booth spaces available on request, from \$250 for the weekend. (Booked prior to June 15th.)

Please get your application in as soon as possible to be considered by our juried Vendor Selection Committee. A **cheque for your space is required at the time of your application** and will be cashed if your application is accepted.

2) Booth space is available to approved regional organizations conducting fundraising through the sales of tickets and/or products at a 50% discount. "Information Only" booth space is also available to approved regional organizations at a 75% discount.

3) This year, the Grand Valley Agricultural Board may offer a limited number of special complimentary or subsidized exhibition spaces to deserving organizations, exhibitors and presenters.

Consideration is given based upon the following:

- the value of the exhibitor's proposed space to the current year's theme (eg. Honeybees & Butterflies); and/or
- a not-for-profit organization's contribution to the community and to this year's Fall Fair; and/or
- willingness to present a demonstration or presentation on the main stage or demo area; and/or
- registered charity groups approved by the Board.

(Please check off all that apply above, for consideration by the Board, prior to June 1st, 2016)

Please note that ALL vendor requests will be juried and some applications may not be accepted. Acknowledgement of insurance must accompany the application, by request of the G.V.A.S. Insurers.
